Robert Kaplan reported that he talked to ESS about the camera and was told that they would not replace the camera that was not working properly and the HOA could sue him. Need to find someone new and get a SOW.

Treasurer's Finance Report: Given by Felicia Rue. She has sent a three-month PL comparison to the Board prior to the meeting. It doesn't compare to the statements. There is a variance of \$18,018.53 shortfall and a variance of \$43,713.90 in income. Expenses overbudget is landscape extras, pest control and brush clearance. The pest control is due to rabbit control. The additional brush clear should be charged to reserves. The landscape extras need to be reviewed.

Year end audit has a cash balance of \$961,126. There were no findings for year end. A reserve study needs to be done this year.

Water usage is down due to the rains.

Eugene Eng reported 121 ballots received. A quorum was reached. 115 ballots were needed for the quorum. Each candidate received one plus in votes. Mary Jo Ammon and Robert Kaplan were elected to serve a two-year term. Brendan Devlin and Bill
